### Sub : Minutes of the Bio-Medical Waste Management Committee Meeting

1. A meeting of the Bio-Medical Waste Management Committee of this Hospital was held on 24 March 2021 at 3 p.m under chairmanship of the undersigned for the half year ending 30 June 2021. The following members were present:

2. The following points were discussed:

- a. Training of all staff and helpers involved in handling Bio-Medical Waste has been carried out in a phased manner during the last six months. A record of details of personnel trained is being maintained centrally. 127 personnel were trained in batches of 12-15 each.
- b. Yearly health checkup of all personnel handling Bio-Medical Waste is being carried out and up to date records maintained.
- c. Training of new entrants to the hospital was reviewed. Those whose training was due were identified and their names included in the training schedule for the half year ending June 2021.
- d. Precautions to be taken against the emerging threat of the Covid-19 pandemic were discussed in detail and guidelines for safe disposal of used PPE, masks, gloves, etc. were emphasized. Guidelines issued by the Government about Covid-19 waste management protocols were discussed and reinforced.
- e. Schedule of training of staff during the next half year was finalized and intimated to all concerned.

f. The last audit(s) carried out to check the efficiency of Bio-Medical Waste collection, transport, storage and disposal procedures in the hospital were ratified and detailed procedure for the next audit was drawn up.

g. The quality of different colour-coded non-chlorinated bags used in Bio-Medical Waste management was checked and it was clarified that replacing them with compostable bags is still pending.

h. Members were requested to bring out any practical difficulties encountered in the training and allocation of man power and disposal procedures of Bio-Medical Waste and to suggest/take appropriate remedial measures.

i. All personnel involved in handling Bio-Medical Waste are being continuously instructed to exercise due care in the discharge of their duties so that the chances of occurrence of any accident/spill is minimized. SOP of spill management was reiterated for everyone's benefit.

j. All functionaries were requested to remain vigilant in the performance of their duties and ensure that updated guidelines of Bio-Medical Waste disposal are strictly followed at all times.

k. The importance of wearing PPE, masks & gloves, frequent hand washing for at least 20 seconds at a time and maintaining social distancing are vital in the fight against Covid-19.

3. There being no further points, the meeting was declared closed and it was decided that the next meeting would be held in September 2021.

- b. Yearly health checkup of all personnel handling Bio-Medical Waste is being carried out and upto date records maintained.
- c. Training of new entrants to the hospital was reviewed. Those whose training was due were identified and their names included in the training schedule for the half year ending December 2021.
- d. Precautions to be taken against the ever present threat of the Covid-19 infection were reiterated. Guidelines for safe disposal of used PPE, masks, gloves, etc. were re-emphasized. Guidelines issued by the Government about Covid-19 waste management protocols were reviewed and reinforced.
- e. Schedule of training of staff during the next half year was finalized and intimated to all concerned.

- f. The last audit(s) carried out to check the efficiency of Bio-Medical Waste collection, transport, storage and disposal procedures in the hospital was ratified and detailed procedure for the next audit was drawn up.
- g. The quality of different colour-coded non-chlorinated bags used in Bio-Medical Waste management was checked and it was clarified that replacing them with compostable bags is still pending because of their non availability in the market.
- h. Members were requested to bring out any practical difficulties encountered in the training and allocation of man power and disposal procedure of Bio-Medical Waste and to suggest/take appropriate remedial measures.
- i. All personnel involved in handling Bio-Medical Waste are being continuously instructed to exercise due care in the discharge of their duties so that the chances of occurrence of any accident/spill is minimized. SOP of spill management was reiterated for everyone's benefit.
- j. All functionaries were requested to remain vigilant in the performance of their duties and ensure that updated guidelines of Bio-Medical Waste disposal are strictly followed at all times.
